PROJECTS, INVESTMENTS & INFRASTRUCTURE

Africent Group Holdings is a diversified investment company with a focus on tech startups and infrastructure projects. The company's portfolio includes successful and unsuccessful ventures, showcasing a willingness to take risks and invest in emerging markets.

In 2017, Africent Group launched Hello Delivery, a food and package delivery service start-up through mobile app development. The company test-piloted the service in Accra, Ghana, and later launched in the United Kingdom in 2018. The total amount invested in this venture was \$129,000 USD. Hello Delivery has since been exited.

In another venture, Africent Group invested \$79,500 USD in an e-commerce company called

Ecommodityexpress.com, which was not successful and was subsequently discontinued. In 2020, Africent Group saw an opportunity in the emergence of COVID-19 and invested in Kreekafrica, a freelance software platform. The total investment in Kreekafrica was \$364,000 USD.

Africent Group has also invested in infrastructure projects, specifically in two sizable projects with 1080 square meters of warehouse each on 5,000 square meters of land. These projects are fully operational and were completed in 2021. The total investment in these projects was \$425,000 USD, and they are currently valued at over \$700,000 USD each. Overall, Africent Group Holdings has a diverse portfolio of investments that highlight the company's willingness to take risks in emerging markets.

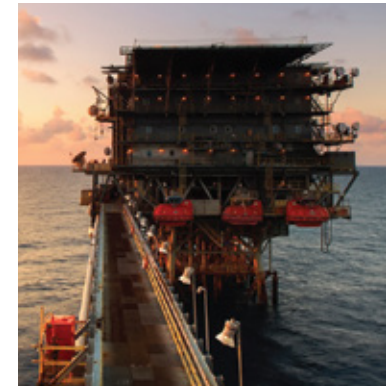
